Canasil Closes \$270,000 First Tranche of Non-brokered Private Placement

Vancouver, December 6, 2013 - Canasil Resources Inc. (**TSX-V: CLZ**, **DB Frankfurt: 3CC**, "Canasil") announces closing of the first tranche of the non-brokered private placement announced on December 3, 2013, for gross proceeds of \$270,000 consisting of 3,000,000 units at an exercise price of \$0.09 per unit as detailed below. No commission or finder's fee is payable with respect to this tranche of the placement, which is subject to final approval by the TSX Venture Exchange ("the Exchange").

Each unit will consist of one common share of the Company and one-half of one share purchase warrant (a "Warrant"); each full Warrant will entitle the holder to purchase one common share of the Company at a price of \$0.15 within one year of closing. If the closing price of the Company's shares equals or exceeds \$0.30 per share for a period of ten consecutive trading days following the closing of the private placement, the Company will have the right to accelerate the expiry date of the Warrants by giving the Warrant-holders at least 30 days' written notice.

The shares and warrant shares issued under this tranche of the private placement are subject to a hold period of four months plus one day to April 7, 2014, and the warrants have an expiry date of December 6, 2014.

The proceeds of the private placement will be used for continuing exploration programs on the Company's mineral exploration projects and for working capital.
